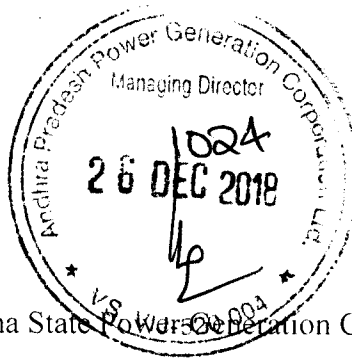

Whereby the present notice fix **Sunday the 20th and Monday the 21st January 2019** for sittings of the committee for preliminary hearings.


The employers and the employees individually and through their associations may submit their written submissions, so that future dates, convenient to the parties, may be fixed for further hearings.
