Sub:-Estt. - APGENCO – AP Re – Organization Act 2014 – Bifurcation of Employees between APGENCO and TSGENCO - 254(252+2) - Finally allocated from TSGENCO to APGENCO – Payment of pay and allowances for the period from 05.01.2020 to 09.07.2020 – Instructions – Issued.

The bifurcation of employees has been finalized and all the 254 (252 Employees+2Pensioners) finally allocated from TSGENCO to APGENCO and Posting orders were issued on 09.07.2020 to the employees in different Generating Stations/HQ of APGENCO & APPDCL.

In continuation of the directions of Hon'ble Justice D.M.Dharmadhikari, (One Man Committee) and orders issued as per para 5(b) of the G.O.O.432 dt.27.07.2020, the following further instructions are hereby issued to all the station DDOs of APGENCO/APPDCL and Pay Officer of APGENCO for payment salary and allowances to the 252 Employees and pension to the 2 Nos pensioners for the period from 05.01.2020 to 09.07.2020.

- a) Pay the Salary and allowances as applicable at corporate office i.e. Corporate allowance, CCA & Medical Allowances to all the 252 No's employees and eligible pension to 2 Nos Pensioners, 100% for the period from 05.01.2020 to 29.02.2020 and 50% for the month of March 2020.
- b) Pay the eligible Allowances for the period from 1st April,2020 to 9th July,2020 (the date of issue of posting orders by APGENCO) i.e. Corporate allowance, CCA and Medical Allowance in addition to the allowances already given.

- c) The finally allocated employees from TSGENCO to APGENCO are entitled for payment of 100% Salary/Pension and Allowances as applicable at corporate office for the month of May 2020 duly considering the amounts already paid and as stated above by carrying out deduction of recoveries as per norms.
- d) The recoveries and remittances in respect of finally allocated employees from TSGENCO to APGENCO from January 2020 to June 2020 shall be done by the respective DDOs of APGENCO/APPDCL only.

All the Station Heads, DDOs of APGENCO/APPDCL and Pay Officer of APGENCO are requested to take necessary action accordingly.
